Simultaneously, the city had approved plans hastily prior to a plans reviewer's retirement. The state flagged discrepancies, and the newly assigned city reviewer backtracked the permit approval to coordinate with DOH.

The project was now in jeopardy:

- State reviewers were frustrated and cautious
- City approvals were under scrutiny


- A contractor was already mobilized
